

BISCUIT EATER GRIFFONS PURCHASE AGREEMENT

INTRODUCTION

This Purchase Agreement ("Agreement") is made and entered into by and between the Seller (BISCUIT EATER GRIFFONS) and the Buyer (the individual or entity purchasing the dog) on this ____ day of _____, 20____. The purpose of this Agreement is to outline the terms and conditions under which the Buyer will purchase a specific dog from the Seller, thereby ensuring both parties are adequately protected and informed.

DEFINITIONS

Seller: The individual or entity offering the dog for sale.

Buyer: The individual or entity intending to purchase the dog.

Dog: The animal being purchased, specifically identified by breed, age, and registration details.

Registration Papers: Documents that establish the dog's pedigree and breed certification.

Health Guarantee: Warranty provided by the Seller regarding the health of the dog at the time of sale.

If, within this period, the Dog is diagnosed with a congenital or hereditary defect that significantly impacts quality of life, as verified by a licensed veterinarian, the Buyer shall be entitled to:

4.3 Buyer's Responsibilities:

The Buyer agrees to have the Dog examined by a licensed veterinarian within 30 days of taking possession. If the Dog is found to have a pre-existing condition not disclosed by the Seller, the Buyer must notify the Seller within 24 hours of the veterinary examination.

The Buyer agrees to maintain appropriate preventative health care including, but not limited to:

- Regular veterinary check-ups
- Proper vaccination schedule as recommended by veterinarian
- Preventative parasite control
- Appropriate diet and exercise

Failure to comply with these responsibilities may void the health guarantee outlined in Section 4.1.

5. TRANSFER OF OWNERSHIP

5.1 Date of Transfer:

Ownership of the Dog shall transfer from Seller to Buyer on ____/____/____ upon receipt of payment in full.

6. RETURN POLICY

6.1 Conditions for Return:

The Dog may be returned to the Seller under the following conditions:

- Health issues covered under the health guarantee in Section 4.1
- The Buyer can no longer care for the Dog (subject to terms below)
- Other conditions: _____

If the Buyer can no longer care for the Dog at any point in the Dog's life, the Buyer agrees to contact the Seller before rehoming, surrendering to a shelter, or otherwise transferring ownership of the Dog.

6.2 Time Frame for Returns:

For health guarantee returns, the Buyer must notify the Seller within 30 days of discovering the health issue.

For non-health related returns:

- ☒ Within 14 days: Refund of 50% of purchase price
- ☒ Within 30 days: Refund of 25% of purchase price

The Buyer is responsible for all transportation costs associated with returning the Dog to the Seller.

7. MISCELLANEOUS PROVISIONS

7.1 Governing Law:

This Agreement shall be governed by and construed in accordance with the laws of the Province of Manitoba. Any disputes arising under this Agreement shall be resolved in the courts of Canada.

7.2 Amendments:

Any modification or amendment to this Agreement must be made in writing and signed by both the Buyer and Seller to be valid and enforceable.

7.3 Severability:

If any provision of this Agreement is held to be invalid or unenforceable, such provision shall be struck, and the remaining provisions shall be enforced to the fullest extent permitted by law.
